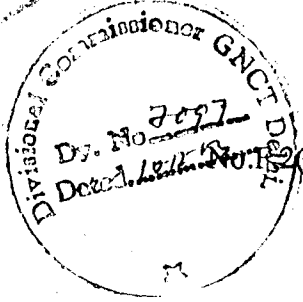

NOTIFICATION

No.F.2(3)/Fin.(E-I)/2003-04/ : In supersession of this Government's Notification No. F.2(3)/Fin.(E-I)/2003-04/(ii)/135 dated 20th May, 2003 and in exercise of the powers conferred by section 9 of the Indian Stamp Act, 1899 (2 of 1899) read with the Government of India, Ministry of Home Affairs Notification S.O.1726/ No.F.2/5/61-Judl.II dated the 22nd July, 1961, the Lieutenant Governor of the National Capital Territory of Delhi is pleased to reduce the stamp duty to three percent in respect of the following instruments as described in Schedule - 1A of the said Act in its application to the National Capital Territory of Delhi, cases of the transaction of immovable property where the owner liable to pay such duty is a woman either individually or severally :-

(1) Under Schedule - 1A :

18-Certificate of sale, 23 - Instruments of conveyance, 31 - Exchange, 32 - Further charge on mortgage property, 33 - Gift, 35, Lease { only in respect of 35(a) (iii), (iv), (v), (vi), (vii), (viii), 35(b) and 35(c) and subject to the stipulation made in column entitled "proper stamp duty" in Schedule - 1A}, 40(a) - Mortgage, 48 (f) - Power of attorney with consideration, 54(a) - Reconveyance, 63 - Transfer of Lease, 64(a) - Trust :

Provided that in cases of jointly held immovable property, the reduced rate of stamp duty specified above shall apply only to the share(s) held by woman/women.

This notification shall come into force with immediate effect and shall remain in force till 31st day of March, 2004.

This notification shall extend to the whole of the National Capital Territory of Delhi.
